Fund Description

The investment objective of the Arqaam Islamic Income Fund (a sub-Fund of Arqaam Islamic Funds (OEIC) PLC) is to invest in securities and or instruments with the aim to provide the Shareholders with Shari'ah compliant returns. The Arqaam Islamic Income Fund will only invest in Shari'ah compliant securities and instruments approved by the Shari'ah Supervisory Board. The Arqaam Islamic Income Fund will target an annual average return of 5%, net of Fees.

Fund Manager's Commentary

The "C" share class was up 2.50% in November, while the FTSE Ideal Ratings was up 2.72% for the month. On a YTD basis the "C" share class is down 3.73% while the index is down 7.04%. The reasons for the monthly under-performance and the annual out-performance are the same and that is the lower duration we are maintaining in the portfolio versus the Index

November was the strongest month of the year for all fixed income markets, as a slightly lower inflation number in the US caused interest rates to come down sharply and also caused a strong rally in risk appetite which allowed credit spreads to compress. We recovered almost half of the YTD loss in the fund, in November. Our best performers were the Pakistan 2022 Sukuk which recovered to Par once the Government confirmed repayment and the Indonesia 2050 Sukuk due to its long duration.




