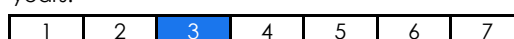

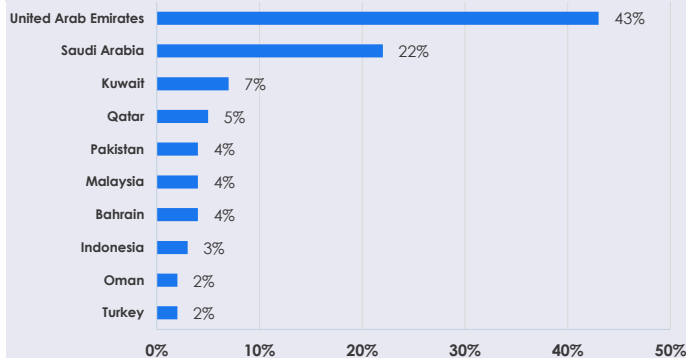

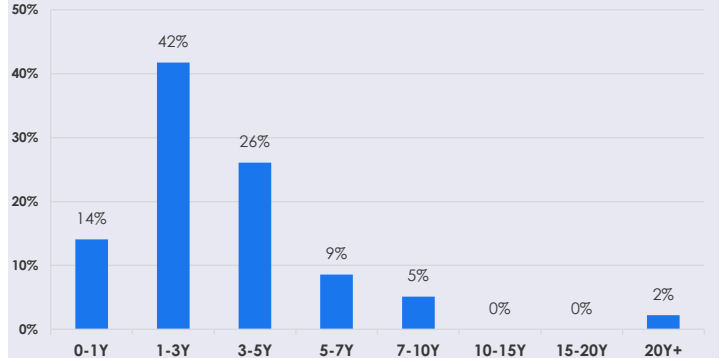

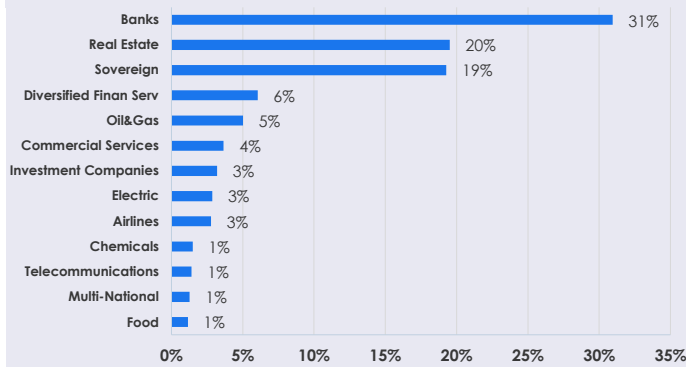
## Top 10 Countries



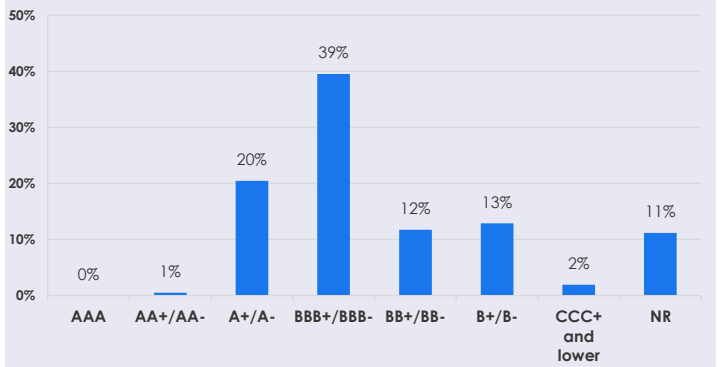
## Bond Maturity Profile
