

Investment Overview

The Protected Cell is dedicated to investing, on a Shariah-compliant basis, in one or more share classes (each, an "Underlying Share Classe") of Franklin Templeton Shariah Funds – Franklin Shariah Global Multi-Asset Income Fund (the "Underlying Master Fund"). The investment objective of the Underlying Master Fund is to maximise income while maintaining prospects for capital appreciation. The Underlying Master Fund will primarily invest in a diversified portfolio of Shariah-compliant equity and fixed income securities (including noninvestment grade securities) issued by government, government-related and corporate entities located in developed, developing and emerging countries.

What are the Risks?

Listed below are the 'Certain Risk Factors' relating to an investment in the Protected Cell: **Credit risk**: the risk of loss arising from default that may occur if an issuer fails to make principal or interest payments when due. This risk is higher if the Fund holds low-rated, sub-investment-grade securities. **Currency risk**: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations. **Derivative Instruments risk**: the risk of loss in an instrument where a small change in the value of the underlying investment may have a larger impact on the value of such instrument. Derivatives may involve additional liquidity, credit and counterparty risks. **Emerging markets risk**: the risk related to investing in countries that have less developed political, economic, legal and regulatory systems, and that may be impacted by political/economic instability, lack of liquidity or transparency, or safekeeping issues. **Foreign Currency risk**: the risk of loss arising from exchange-rate fluctuations or due to exchange control regulations. **Shariah compliance risk**: the risk that the restriction to invest only in Shariah-compliant securities may place the Fund at a comparative disadvantage vs. funds that do not have this restriction. Returns to shareholders may also be reduced due to payments to Shariah approved charities to "purify" dividends.

Glossary

Ongoing Charges Figure (OCF): The Ongoing Charges Figure (OCF) includes the fees paid to the management company, the investment manager and the depository, as well as certain other expenses. The OCF is calculated by taking the relevant main material costs paid out over the 12-month period indicated and dividing them by the average net assets over the same period. The OCF does not include all expenses paid by the fund (for example, it does not include what the fund pays for buying and selling securities). Distribution Yield: The Distribution Yield reflects the amounts that may be expected to be distributed over the next 12 months as a percentage of the Net Asset Value of the class as at the reported date. It is based on a snapshot of the portfolio on that day. It does not include any subscription charges and investors may be subject to tax on distributions. Comparator: Benchmark is used for comparing Fund performance, but is not a constraint to Fund Investment.
