

# DIB Visa Cards FIFA World Cup Qatar 2022™ Raffle Draw Offer Terms and Conditions

The Raffle Draw Offer ("Offer") is governed by Raffle Draw Offer Terms and Conditions ("Offer Terms and Conditions") of Dubai Islamic Bank P.J.S.C ("DIB"). The Offer is subject to (i) Dubai Islamic Bank's Banking Services Agreement Terms and Conditions ("DIB BTC"), (ii) Credit Card Terms & Conditions and Debit Card T&Cs. The Customer irrevocably and unconditionally releases and discharges Dubai Islamic Bank, its affiliates and their directors, officers and employees from any and all liabilities arising and/or in relation to the Offer Terms and Conditions. For avoidance of doubt, the Customer, shall not assert any claim, and waives any right to assert any claim(s) against Dubai Islamic Bank, its affiliates and their directors, officers and employees for any loss, damage suffered or alleged and/or legal actions, costs or expenses of whatsoever nature arising out of the Offer Terms and Conditions/or Offer.
- 30. The Customer acknowledges and agrees that he/she has read, understood and unconditionally accepted the terms and conditions herein.
