1. (b) Any payment received from the Issuing Bank following our failure to present the required documents to obtain payment under the DC shall be used to offset any of DIB's charges, fees, costs and , expenses still outstanding, after payment / settlement of which DIB shall pay over to the transferee the amount due to him. The balance, if any, will be paid to us in accordance with our instructions.
(c) We hereby authorise DIB at any time and without further advice to debit our account (s) maintained with them for all payments ,charges fees, VAT, due or may be due in future which incurred in connection with this LC or any other related services and if for any reason whatsoever deem it fit to be debited from our account with full amount.
3. We hereby agree and undertake to indemnify DIB against all claims, losses, payment, expenses, costs (including legal costs on an indemnity basis) consequences and/or liabilities of any kind whatsoever, directly or indirectly arising from, or relating to the transfer of this LC and against all payments made by DIB in respect of such consequences and/or liabilities, including cost as between solicitor and client and all or any sums demanded by DIB for the defense of any proceeding, action, suit or claim brought against DIB.
4. The transfer of the LC and the transferred LC shall be governed by the provisions of the Uniform Customs & Practice for Documentary Credits and applicable rules of ISBP latest version.
5. We agree to any terms which DIB may set out in the transfer advice in consideration of their agreeing to transfer the LC at our request.

- 6. Payment shall be effected by DIB only upon receipt of funds from the Issuing Bank.
- 7. It is understood that DIB has the full right to preclude from any transactions at any point in time where it finds necessary to adhere with the compliance/Sanctions/Law of land as required.
- 8. We agree & undestand that any alteration/addition in this application needs to be signed by the Transferor (us).
- 9. We understand and agree If the original LC requires the name of the applicant to appear in any document (other than the invoice), then DIB will have to reflect this requirement in the transferred LC, thereby allowing the second beneficiary to see the applicant's name.
- 10. This Application shall be governed and construed in accordance with the laws of the Emirate of Dubai, and applicable federal laws of The United Arab Emirates, including specifically Part Six of Federal Law No. 50 of 2022 relating to Commercial Transactions of Islamic Financial Institutions.
- 11. The Dubai Courts shall have non-exclusive jurisdiction in respect of any dispute arising under this Application
